LAWYER REFERRAL SERVICE MEMBERS GUIDE

Calls from the public will come directly to your office on a rotating basis. You will begin receiving calls about 9:30 and will continue receiving them until the number is forwarded to another office on the following day. The member attorney should try to be available in the office on the days assigned to him/her. The number of days you receive in a cycle depends on the number of participants in the LRS.

If you do not wish to handle a particular case, you should refer it to another member of the LRS from the list provided, broken down by category and listing the attorneys who do practice in that area of law.

DAILY PROCEDURES

- 1. Calls will be forwarded from the GCBA office
- 2. On the day you will be receiving calls, please answer your telephone, "law offices". This will avoid confusing the public.
- 3. Inform the caller that the initial half-hour consultation is only **\$25.00.**
- 4. If you choose not to handle a particular call, refer the caller to a LRS member attorney from the enclosed list.
